The information contained in this report is based on preliminary information and is provided for hazard awareness and training purposes only. Official mishap data should be obtained from the Naval Safety Center.

The Naval Safety Center received the following reports for September 2020

I regret to report in September; we lost four service members in motorcycle crashes. As we start a new FY, reach out to your motorcycle riders and review these crashes.

The weather is ideal for riding; ensure your new riders have at least a LVL I completion course before they even ride. Now is also a perfect time to conduct a stand-down for motorcycle safety. Go out to the parking lot with the Motorcycle Safety Foundation T-CLOCS Inspection Checklist (link below) and do a safety check on your motorcycle to ensure they are current on the state inspection (if required) and mechanically in good shape.

Risk Management Information-Streamlined Incident Reporting, RMI-SIR – For those of you entering motorcycle mishaps into the new injury RMI-SIR system, please ensure that the narrative does not include any Personally Identifiable Information, PII (i.e., name, age, gender, etc.) but does include the required operator training LVL I or LVL II (example: LVL (May 2019) LVL II (Jan 2020). This information will allow better reporting in the MSR Rider down report.

When reporting mishaps, MORE detailed information is better! Whether it is an OPREP or RMI report, ensure when reporting to your safety personnel, you are providing a complete, thorough, and accurate account of the mishap.
