



# RMI becomes sole reporting tool

Risk Management Information (RMI) is replacing a number of legacy reporting systems to include web-enabled safety systems, enterprise safety application management system, various shipyard databases and other stand-alone systems. RMI will deliver improved safety capabilities to the fleet by providing relevant information and actionable safety data for managing risk and for making data-driven risk-based decisions.

Risk Management Information is the sole official Department of the Navy (DON) web-based database application for mishap reporting and safety program management as of Jan 1, 2026. The Naval Enterprise must transition to RMI by Jan 1, 2026 and migrate historical data by Oct 1, 2025.

RMI streamlined incident reporting (SIR) was released throughout the DON in 2020 to promote the Navy's digital transformation. The RMI Program of Record (POR) database application is required to be used for reporting, recording and analyzing all mishaps, hazards (including near misses), and incidents in accordance with OPNAV M-5102.1. The RMI POR database is Department of Defense Common Access Card enabled, and access links are available on the Naval Safety Command website at <https://navalsafetycommand.navy.mil/>.

After Jan 1, 2026, input of safety related information into any systems other than RMI is prohibited. Safety related information includes injuries and illnesses, which are already required, as well as safety program management information, such as inspections, hazards from inspections, medical surveillance, motorcycle rider data and other information required by OPNAV M-5100.23 that has been maintained in other systems in the past.

These comprehensive RMI courses are available entirely online, offering interactive sessions and resulting in a completion certificate for your Fleet Training Management and Planning System training jacket. With courses starting at various times throughout the dates listed, find a time that best fits your schedule and take advantage of this valuable training opportunity.

All sessions are stand-alone—you must register for each topic separately.

**How to Enroll:** To secure your spot in the RMI training courses, enrollment must be completed via the eNTRS (Enterprise Naval Training Reservation System). Please follow the steps outlined below to request your quota through eNTRS, ensuring timely processing and confirmation of your enrollment.

To request a quota for a course:

Step 1: Complete the course prerequisite by requesting a simulator account--<https://sim.afsas.safety.af.mil/>.

Step 2: Request an eNTRS account. If you do not have access to eNTRS, you can request access on the bottom of the Corporate Enterprise Training Activity Resource Systems homepage: <https://main.prod.cetars.training.navy.mil/cetars/main.html>

Step 3: Access eNTRS: <https://app.prod.cetars.training.navy.mil/eNTRS/>

Step 4: Use the "Request Menu" to search by Course Development Program.

Step 5: Follow the prompts to request your quota. Please ensure you provide a correct student email address. If the email address is incorrect, the student will not receive course notifications. Without the notifications they will end up being a no-show.

Tip: eNTRS users within your Unit Identification Code (UIC) can request quotas for others within the same UIC.

These RMI courses equip you with the knowledge and skills needed to maintain data accuracy and integrity within the system. We strongly encourage you to explore the catalog and enroll in the courses that will best enable you to contribute to reliable risk management reporting and analysis.
